In August 2018, the United States enacted the National Defense Authorization Act for Fiscal Year 2019 (US Government appropriations and procurement) (“NDAA”). The NDAA states, among other things, that certain surveillance products from manufacturers listed in the NDAA are expressly forbidden for use in US Government-related video surveillance deployments.

Snap One affirms that our products listed in the chart below are compliant with the NDAA.
